# **Mixr Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to mixr.dating and the Mixr mobile application, for which Mixr Inc. governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Mixr Inc. include mixr.dating, Mixr, the Mixr mobile software application, and any subdomains of the format "\*.mixr.dating". The Mixr application is an event-based dating platform available for use in the United States. By using the Mixr application, you consent to the data practices described in this statement.

### **Collection of Your Personal Information**

In order to better provide you with products and services offered, Mixr may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

Mixr may also collect demographic information, as is voluntarily provided by you, such as your:

- Age
- Gender
- Religion
- Occupation
- Education
- City of residence
- Hometown

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Mixr's public profiles, this information may be collected and used by others. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include:

- (a) registering for an account;
- (b) entering a sweepstakes or contest sponsored by us or one of our partners;
- (c) signing up for special offers from selected third parties:
- (d) sending us an email message;
- (e) submitting your credit card or other payment information when ordering and purchasing products and services (see section titled "Collection and Use of Your Payment Information").

To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

# Collection and Use of Your Information from Google

Mixr has integrated Google account oAuth sign in to offer a simple account creation process for its users. By using Google oAuth login, you consent to Mixr accessing your basic Google profile information for use within the app, including:

- First and Last name
- Email address (associated with the selected Google account)

Mixr stores and uses Google account data in the same ways it uses native Mixr account information. The use of these data is detailed below ("Use of your Personal Information").

# **Collection and Use of Your Information from Apple**

Mixr has integrated Apple account oAuth sign in to offer a simple account creation process for its users. By using Apple oAuth login, you consent to Mixr accessing your basic Apple profile information for use within the app, including:

- First and Last name
- Email address (associated with the selected Apple account if disclosed in oAuth flow)

Mixr stores and uses Apple account data in the same ways it uses native Mixr account information. The use of these data is detailed below ("Use of your Personal Information").

# **Collection and Use of Your Payment Information**

If you purchase products and services directly from Mixr (not via Mixr's third party ticketing platform partners), Mixr uses Stripe to handle all billing and credit card information. This information is used to complete the purchase transaction. Mixr never stores your billing information, either on Mixr servers or on your personal device.

Products and services purchased via Mixr's third party ticketing platform partners, including Mixr Dating Pool add-on tickets, all purchasing and billing information data is handled by the partner platform, and not Mixr.

Mixr collects and uses your personal information to operate and deliver the services you have requested. Mixr may also use your personally identifiable information to inform you of other products or services available from Mixr and its affiliates. Some personal information relating to your public profile (including first name, age, occupation, religion, city of residence, hometown, and education) may be made publicly visible to other users of Mixr when voluntarily checking in to a Mixr event, venue, etc.

### Stripe

Mixr uses Stripe's features to process payments. This includes any features listed <u>here</u>. Mixr uses Stripe to collect and store user payment information including but not limited to:

- Bank account (ACH payment setup)
- Credit card
- Google pay
- ...any other payment integration supported by Stripe (see Stripe documentation <u>here</u>)

By agreeing to the terms set forth in this document, you agree to all the terms and conditions set forth by Stripe here that apply to Mixr payment collection use-cases.

#### **Apple In-App Purchases**

Mixr may use Apple's in-app purchases functionality as a proxy for collection of payment.

# **Sharing Information with Third Parties**

Mixr may sell, rent, or lease customer information to third parties for the following reasons:

- To provide optimal platform experience Mixr may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Mixr may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Mixr, and they are required to maintain the confidentiality of your information. Mixr may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to:
  - (a) conform to the edicts of the law or comply with legal process served on Mixr or the site;
  - (b) protect and defend the rights or property of Mixr; and/or
  - (c) act under exigent circumstances to protect the personal safety of users of Mixr, or the public.

# **Opt-Out of Sale or Disclosure of Personal Information to Third Parties**

In connection with any personal information we may sell or disclose to a third party for a business purpose, you have the right to know:

- The categories of personal information about you that we sold and the categories of third parties to whom the personal information was sold; and
- The categories of personal information that we disclosed about you for a business purpose. You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt-out of the sale or disclosure of your personal information. If you exercise your right to opt-out of the sale or disclosure of your personal information, we will refrain from selling or disclosing your personal information, unless you subsequently provide express authorization for the sale or disclosure of your personal

### **Tracking User Behavior**

Mixr may keep track of the websites and pages our users visit within Mixr, in order to determine what Mixr services are the most popular. This data is used to deliver customized content and advertising within Mixr to customers whose behavior indicates that they are interested in a particular subject area.

# **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Mixr. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Mixr website.

### **Use of Cookies**

The Mixr website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Mixr pages, or register with Mixr site or services, a cookie helps Mixr to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Mixr website, the information you previously provided can be retrieved, so you can easily use the Mixr features that you customized. You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Mixr services or websites you visit.

# **Security of your Personal Information**

Mixr secures your personal information from unauthorized access, use, or disclosure. Mixr uses the following methods for this purpose:

- TLS Protocol
- Usage of only connections utilizing HTTPS certificates
- Data encryption at REST via AWS DynamoDB
- "Principle of Least Access" usage for all user-service interactions, restricting service & data access to only what is absolutely necessary in a given exchange

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol. We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

### **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records. Please note
  that we may not be able to comply with requests to delete your personal information if it is
  necessary to:
- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or

• Otherwise use your personal information, internally, in a lawful manner that is compatible with

the context in which you provided the information.

**Minors Under Eighteen** 

Mixr does not knowingly collect personally identifiable information from minors under the age of

eighteen. If you are under the age of eighteen, use of the Mixr platform is a violation of the Terms of

Service

We respect your privacy and give you an opportunity to opt-out of receiving announcements of certain information. Users may opt-out of receiving any or all communications from third-party partners of Mixr

We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our website, and/or by updating any privacy information. Your continued use of the website and/or Services

available after such modifications will constitute your: (a) acknowledgment of the modified Privacy

Policy; and (b) agreement to abide and be bound by that Policy.
